RULES AND REGULATIONS

1. Free Entry for GMs, IMs, WGMs, WIMs, players.
2. System of Play : The Tournament will be played under FIDE's Laws of Chess and the Swiss system. A total of 7 rounds shall be played.
3. Default Time : Default time for arriving to the chessboard is 15 minutes.
4. Time Control : The rate of play shall be 30 minutes with an increment of 20 seconds per move from move number one
5. Protest : Protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs. 1000/- within 15 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is up held.
6. In case of tie prizes will not be shared. One player will get 1 higher prize only.
7. Appeals Committee : Before the commencement of the tournament, 3-member appeals committee shall be formed by the KSCA/organizers. All the members and reserves shall be from different states. No member of the Committee can vote on a dispute in which a player from his own district is involved and, in such case(s), the reserve member(s) shall take his place in the committee
8. Electronic Devices: All electronic items including wrist watches (all type of watches) are not allowed in the tournament hall.
9. Players have to make their own arrangements for food & accommodation
10. Tie Break: Following is the order of tie-break:
 - (a) Buchholz Cut1
 - (b) Buchholz
 - (c) Sonneborn Berger
 - (d) Direct encounter
 - (e) The greater number of wins (forfeit included)
 - (f) The greater number of wins by black
